

BYLAW NO. 03-11

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE VILLAGE OF PARADISE HILL TO ALLOW FOR A SIGNING CORRIDOR.


The Council of the Rural Municipality of Frenchman Butte No. 501 in the Province of Saskatchewan, enacts as follows:

1. The Rural Municipality of Frenchman Butte No. 501 is hereby authorized to enter into an agreement with the Village of Paradise Hill, the terms of which are attached hereto and marked Exhibit "A", to establish a signing corridor for the purpose of promoting tourism and economic development.
2. The Reeve and Administrator of the Rural Municipality of Frenchman Butte No. 501 are hereby authorized to sign and execute the agreement, the terms of which are set out in Exhibit "A" attached hereto and forming part of this bylaw.

PARTNERSHIP AGREEMENT

BETWEEN:

THE VILLAGE OF PARADISE HILL, a body corporate under the laws of the Province of Saskatchewan, hereinafter called "the Village".

- and -

RURAL MUNICIPALITY OF FRENCHMAN BUTTE No. 501 a body corporate under the laws of the Province of Saskatchewan, hereinafter called "the RM".

WHEREAS: the Village and the RM wish to establish a signing corridor for the purpose of promoting tourism and economic development:

The aforementioned parties hereby agree to the following:

1. A sign corridor shall be established at the following locations:

South side | From: East boundary of the Paradise Hill Meat House property on SE-4-53-24-W3
To: Gravel road access from Highway#3 to Paradise Hill Farm Supply on SW-3-53-24-W3 |
| Highway #3
North side | From: Intersection of Highway#3 and the access road to the Village of Paradise Hill on SW-3-53-24-W3
To: East boundary of the United Agricore property on NE-3-53-24-W3 |
| Highway #3
South side | From: Access from Highway#3 to Weindandl's Fix & Fabricate on NE-3-53-24-W3
To: Point of intersection between Highway #3 and the east boundary of NE-3-53-24-W3 |

2. The Village shall act as administrator of the sign corridor.

3. As administrator of the sign corridor, the village shall be responsible for approving all signs prior to installation, ensuring that all signs meet with standards, as set by the Department of Highways, for placement of signs alongside provincial highways.

4. All signs shall adhere to guidelines designed to create an aesthetically pleasing sign and sign corridor. These guidelines shall be determined by the administrator.


