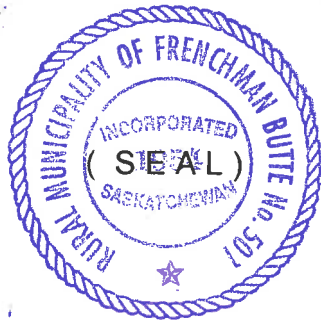


# BYLAW NO. 2013-18

## A BYLAW TO PROVIDE FOR EXEMPTION FROM TAXATION OF CERTAIN PROPERTY PURSUANT TO SECTIONS 295(1) & 298(5) OF THE MUNICIPALITIES ACT

The Council of The Rural Municipality of Frenchman Butte No. 501, in the Province of Saskatchewan enacts as follows:

1. The property listed in "Exhibit A" which is attached hereto and forms a part of this bylaw shall be partially exempt from taxation by the Rural Municipality of Frenchman Butte No. 501 for a five year period.
2. Bylaw No. 2012-07 is hereby repealed.
