## BYLAW NO. 03-11

A BYLAW TO PROVIDE FOR ENTERING INTO AN AGREEMENT WITH THE VILLAGE OF PARADISE HILL TO ALLOW FOR A SIGNING CORRIDOR.

## BETWEEN:

1. A sign corridor shall be established at the following locations:

Highway #3 South side From: East boundary of the Paradise Hill Meat House property on

To:

Gravel road access from Highway#3 to Paradise Hill Farm

Supply on SW-3-53-24-W3

Highway #3 North side From: Intersection of Highway#3 and the access road to the

Village of Paradise Hill on SW-3-53-24-W3

To: East boundary of the United Agricore property on

NE-3-53-24-W3

Highway #3 South side From: Access from Highway#3 to Weindandl's Fix & Fabricate

on NE-3-53-24-W3

To: Point of intersection between Highway #3 and the east

boundary of NE-3-53-24-W3

- The Village shall act as administrator of the sign corridor.
- As administrator of the sign corridor, the village shall be responsible for approving all signs
  prior to installation, ensuring that all signs meet with standards, as set by the Department of
  Highways, for placement of signs alongside provincial highways.
- 4. All signs shall adhere to guidelines designed to create an aesthetically pleasing sign and sign corridor. These guidelines shall be determined by the administrator.
