A BYLAW TO PROVIDE FOR ENTERING INTO A MEMORANDUM OF UNDERSTANDING FOR A RECYCLING BIN COST SHARE WITH THE TOWN OF ST. WALBURG

The Council of the Rural Municipality of Frenchman Butte No. 501 in the Province of Saskatchewan enacts as follows:


1. The R.M of Frenchman Butte No. 501 is hereby authorized to enter into a Memorandum of Understanding for a Recycling Bin Cost Share with the Town of St. Walburg. The Memorandum of Understanding is attached and forms a part of this bylaw, identified as "Exhibit A".
2. The Reeve and the Administrator of the R.M. of Frenchman Butte are hereby authorized to sign and execute the attached Memorandum of Understanding identified as "Exhibit A".
3. Bylaw No. 2015-07 is hereby repealed.

MEMORANDUM OF UNDERSTANDING

BETWEEN:

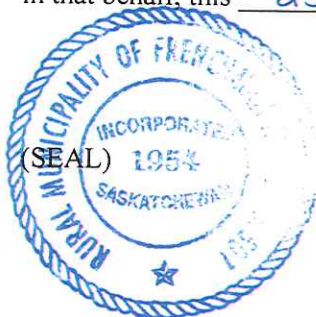
hereinafter referred to as "the Town"

WHEREAS the R.M. of Frenchman Butte No. 501, agrees to a Recycling Bin Cost Share with the Town of St. Walburg, as described below:

NOW THEREFORE the parties hereto agree as follows:

- That the RM of Frenchman Butte No. 501 will contribute 50% of the incurred cost of recycling disposal of the Town of St. Walburg.
- That the RM of Frenchman Butte No. 501 will provide the Town of St. Walburg with a payment of \$1,000.00 monthly (\$12,000.00 annually) which represents approximately half of the recycling costs.
- If half of the recycling costs exceed \$1,000.00 a month (\$12,000.00 annually) the Town of St. Walburg will invoice the R.M. of Frenchman Butte No. 501 the full 50% of the costs of recycling for each fiscal year (January 1 to December 31) less the payments that were provided.
- If half of the recycling costs are less than \$1,000.00 a month (\$12,000.00 annually) the Town of St. Walburg will reimburse the R.M. of Frenchman Butte No. 501 by February 28, of the following fiscal year (January to December), for any amount over 50% of the recycling costs that the R.M. of Frenchman Butte No. 501 paid for the previous fiscal year (January to December).
- The R.M. of Frenchman Butte No. 501 and the Town of St. Walburg shall evaluate the payment amount and schedule on or before February 28 of each year.
- The R.M. of Frenchman Butte No. 501 or the Town of St. Walburg may terminate this Memorandum of Understanding at any time by providing 30 days written notice to the other party.
