1. PURPOSE:

This policy outlines who shall attend final road inspections.

2. DEFINITIONS:

2.1 Council:

Means Council for the Rural Municipality of Frenchman Butte No. 501.

2.2 Final road inspection:

Means the inspection of a road project, whether clay cap, new road construction, or re-construction/improvement of a road, following the completion of a project.

3.0 SCOPE:

This policy defines attendance at final road inspections.

4.0 POLICY:

It is the policy of the RM to authorize the following individuals to be part of final road inspections:

Reeve
Divisional Councillor or Alternate
Municipal Engineer Representative
Contractor Representative
Public Works Coordinator
Public Works Supervisor

5.0 SPECIFIC REQUIREMENTS

Appendix A is to be completed to document information which shall be returned to the municipal office for council information and the municipality's files.

Appendix B the municipality's engineer must provide written notification to the R.M. of Frenchman Butte No. 501 that all the deficiencies have been addressed.

6.0 RESPONSIBILITY/INTERPRETATION/REPEALING:

All Appendices attached to this policy may be amended from time to time based on operational need.

This policy shall be administered and interpreted by the Chief Administrative Officer; however, this policy cannot be amended without Council approval.

This policy replaces all previous policies and resolutions that have been passed by the Council of the Rural Municipality of Frenchman Butte No. 501 with respect to the application of any and all parts of this policy and the terms and conditions contained herein.

This policy shall come into force and take effect on **November 6, 2019** and shall continue in full force and effect until repealed or replaced by subsequent resolution of Council.
