1.0 INTRODUCTION

The Rural Municipality of Frenchman Butte No. 501 (hereinafter referred to as "the RM") is seeking competitive bids from qualified contractors for gravel crushing services. The selected contractor will be responsible for crushing gravel at the RM's designated Frenchman Butte Access pit.

Contractors are invited to submit bids for the provision of the required services in accordance with the terms, conditions and bid response format as specified in this BID.

The purpose of the Request for Bid (RFB) is to identify those contractors capable of meeting the requirements in a feasible, economical and timely manner, and with whom a contract can be entered in to.

By responding to this RFB, each supplier thereby acknowledges that he has reviewed the process, terms, conditions and reserved rights contained in this RFB, and has voluntarily chosen to participate in this RFB subject to those procedures, terms, conditions and reserved rights.

This procurement will be subject to any applicable trade agreement(s).

4.0 SCOPE

4.1 Contractor Responsibilities

The contractor will crush all gravel listed in Table 1 at the designated RM pit. The contractor is expected to manage all aspects of the crushing operation, including but not limited to:

- 4.1.1** Provision of all necessary equipment and labor.
- 4.1.2** Compliance with all applicable safety and environmental regulations.
- 4.1.3** Ensuring quality and consistency of the crushed gravel as per RM specifications.
- 4.1.4** Reference images of the gravel and crushing area are included in Appendix A to provide contractors with visual context regarding material type and site conditions.

4.2 Project Requirements and Contractor Obligations

- 4.2.1** The Contractor shall crush all the gravel listed in Table 1 between **June 1** and **October 31, 2026**. An extension of time required to complete the contract may be granted if agreed upon in writing between the Contractor and the R.M. of Frenchman Butte No. 501.
- 4.2.2** The contractor is responsible to contact the R.M. of Frenchman Butte Municipal Office at (306) 344-2034 eight (8) business days prior to the estimated date of the completion of crushing a gravel pile, in order that arrangement can be made to take measurements.
- 4.2.3** Payment will be made based upon measurements taken by drone, within 30 days of the completion of crushing, with no shrinkage.
- 4.2.4** The Contractor shall provide a detailed scale ticket summary or tonnage report, verified by a certified belt scale or loader scale, for all crushed material prior to the RM conducting drone measurement. This

documentation is required for comparison and audit purposes and must reflect accurate totals by material type.

- 4.2.5 Primary jaw must be capable of crushing rock up to 18 inches in diameter.
- 4.2.6 The Contractor is required to use a radial or telescopic stacker capable of lateral and longitudinal movement for even distribution and mixing of the gravel pile. The stacker must be operated using an appropriate stacking pattern such as the chevron or windrow method to promote material blending and minimize segregation, in accordance with best practices for aggregate mixing.
- 4.2.7 Prior to setup, the Contractor shall inspect the designated crushing area. If ground conditions are determined to be unsuitable for the proper operation of a radial or telescopic stacker, the Contractor must notify the RM in writing at least five (5) business days before setting up the stacker, providing detailed justification and requesting further direction.
- 4.2.8 Failure to notify the RM of unsuitable conditions prior to setup may result in the disqualification of claims related to site limitations and/or application of penalties at the discretion of the RM.
- 4.2.9 The quantity and type of crushed gravel will be in accordance with Table 1 and as described in Table 2.
- 4.2.10 The Municipality shall take random samples from the centre of a stopped conveyor belt to ensure compliance of gravel quality.
- 4.2.11 The Contractor shall complete the *Gravel Crushing Agreement* attached to this *Request for Proposal* and submit it with the tender documents. The R.M. of Frenchman Butte No. 501 will complete the *Gravel Crushing Agreement* with the successful contractor.
- 4.2.12 The Municipality reserves the right to reject any and all *Request for Proposals*. The lowest bid, or any bid, may not necessarily be accepted.
- 4.2.13 The Municipality may extend the contract for the crushing of gravel in excess of the amount listed below at the same rate as the bid amount.
- 4.2.14 The Contractor shall provide two references (name, address, job title, phone number, email address) and describe how the services provided to these references relate to the services you will provide to the R.M.
- 4.2.15 Please attach a list of all equipment to be used on the project.
- 4.2.16 The R.M. of Frenchman Butte No. 501 will be responsible for stripping the pits in advance of crushing.

5.0 BID SUBMISSION FORMAT

Please complete the following pages for evaluation and comparison.

To ensure a bid is considered, all the information requested on the *Bid Submission Form* and *Table 1- Bid Sheet*, must be completed.



6.0 EVALUATION

Each bid will be reviewed to ensure that it is complete and that it complies with the instructions, requirements, and terms and conditions of this RFB. Bids not considered compliant will be rejected at this stage and no further efforts will be applied to them by the evaluation team.

6.1 Price (70% of evaluation)

Each bid will be evaluated to rate how the contractor's price compares with other bids submitted.

6.2 Experience and Reliability (20% evaluation)

The level of contractor experience will be evaluated. The R.M. of Frenchman Butte No. 501 reserves the right to contact any of the contractor's customers who the Municipality believes may be able to verify the information provided about the contractor that would be pertinent to this RFB.

6.3 Project Methodology (10% of evaluation)

Each bid will be evaluated on the efficiency and suitability of proposed methodology and equipment.

7.0 ADDITIONAL TERMS AND CONDITIONS

- 7.1 The R.M. of Frenchman Butte No. 501 will not be responsible for any costs incurred by a contractor in preparing and submitting bids.
- 7.2 In submitting a bid, the contractor agrees that the decision of the Council will be final.
- 7.3 Submission of a response shall not obligate, nor should it be construed as obligating the R.M. of Frenchman Butte No. 501 to accept any such response or to proceed further with the purchase. The R.M. of Frenchman Butte No. 501 may, in its sole discretion, elect not to proceed with the purchase, and may elect not to accept any or all responses for any reason.
- 7.4 Contractors may amend or withdraw their submissions prior to the closing date and time specified in the RFB by way of written or faxed notice to the R.M. of Frenchman Butte No. 501. After the closing date and time, responses may be irrevocable at the discretion of the R.M. of Frenchman Butte No. 501.
- 7.5 Responses submitted shall be final and may not be altered by subsequent offerings or discussions.
- 7.6 A private opening will take place on September 5th, 2025, shortly after 2:00 p.m. All responses and accompanying documentation received under this competition will become the property of the R.M. of Frenchman Butte No. 501 and will not be returned.
- 7.7 The R.M. of Frenchman Butte No. 501 reserves the right to cancel and/or re-issue this RFB at any time for any reason without penalty.
- 7.8 Prices quoted are to be held firm for a minimum of 120 days following the RFB closing date, and shall remain in effect through the duration of the agreement.

- 7.9** Subcontractors must adhere to the same standards as the primary contractor, including legal, safety, and performance specifications. The primary contractor is responsible for ensuring their subcontractors' compliance. Non-compliance by a subcontractor will be considered as non-compliance by the primary contractor.
- 7.10** The successful contractor may, for the purposes of marketing, disclose the R.M of Frenchman Butte No. 501's name and a general description of the services provided to the R.M. of Frenchman Butte No. 501 pursuant to the agreement but shall not indicate in any way that the R.M. of Frenchman Butte No. 501 endorses the contractor's services.

GRAVEL CRUSHING AGREEMENT

This agreement, made in duplicate this _____ day of _____, 20____

BETWEEN:

(hereinafter called the "Contractor")

-And-

The Rural Municipality of Frenchman Butte No. 501

Box 180

Paradise Hill, SK

S0M 2G0

(hereinafter called the "Municipality")

WHEREAS:

(a) The Municipality desires to obtain, and the Contractor desires to provide, services to crush and stockpile gravel and reject sand on the land described as:

- SW 16-54-22 W3M (herein called "Kozinski Pit")
- NW 35-52-25 W3M (herein called "Frenchman Butte Access Pit")

NOW, THEREFORE, the parties agree as follows:

1.0 Deliverables

- 1.1** The Contractor will crush approximately 20,000 cubic yards of aggregate for the Municipality. The crushed gravel will be sourced as follows:
 - 1.1.1** 20,000 cubic yards of Type 105 traffic gravel from the Kozinski Pit, crushed between June 1 and October 31, 2025.
 - 1.1.2** 14,000 cubic yards of Type 117 Chip Aggregate from the Frenchman Butte Access Pit, crushed between June 1 and October 31, 2025.
- 1.2** The Contractor will provide all equipment, labor, materials and other such things as are necessary to crush and stockpile the gravel and reject sand.
- 1.3** The gravel to be crushed by the Contractor shall be done, so far as practicable, in an orderly fashion.
- 1.4** The gravel to be crushed by the Contractor shall be done, so far as practicable, in an orderly fashion.

2.0 Pricing

- 2.1** The prices for crushing as stated in the bid submitted by the contractor and accepted by the Municipality. These prices shall be firm throughout the contract term.

3.0 Subcontracting

- 3.9** All subcontractors, including engineering firms, surveyors, and any third-party service providers, must be pre-approved by the Municipality. Bidders must list intended

subcontractors and their qualifications in their proposals. The RM reserves the right to reject any subcontractor that fails to meet the required standards.

4.0 Penalties

- 4.9** The Contactor shall complete all work described in this agreement by the dates outlined, or a penalty of \$500/day may be applied at the discretion of the Municipality until the work is completed.

5.0 Payment

- 5.9** The payments from the Municipality to the Contractor will be made at the completion of work and at the first R.M of Frenchman Butte No. 501 Council Meeting following the receipt of the gravel pile and reject sand pile measurements from the R.M.'s Engineer. The Contractor shall provide an accurate tonnage report based on their scale system (belt or loader scale), broken down by gravel type, prior to the RM's drone measurement. This report must be submitted in writing and will be used for comparison and verification of volume. No shrinkage will be calculated. 10% holdback will be retained until the following documents are received by the R.M.:
- 5.9.1** Provincial Sales Tax Clearance from the Saskatchewan Provincial Treasurer;
 - 5.9.2** Verification that Worker's Compensation Board assessments have been paid;
 - 5.9.3** Completed contractor's affidavit of payment to sub-contractors.

6.0 Gravel Quantity

- 6.9** There is no guarantee of the quantity of gravel present. The Contractor shall crush up to the estimated amounts if possible.
- 6.10** The volume of gravel to be crushed may be increased at the listed bid price. The contract deadline may be extended to allow time for this increased volume.

7.0 Quality Assurance

- 7.1** The Contractor guarantees that all gravel crushed under this agreement will meet the specified standards.
- 7.2** The Contractor shall provide all necessary documentation to verify compliance with these standards upon request.

8.0 Contract Duration

- 8.1** This Agreement shall commence on the date of signing and will continue in effect until the completion of deliveries unless terminated earlier in accordance with the provisions of this Agreement.

9.0 Termination

- 9.9** The Municipality may terminate the Agreement without cause by providing sixty (30) days written notice to the Contractor.

10.0 Liability and Insurance

- 10.1** The Contractor shall maintain adequate insurance coverage to protect against all liabilities, damages, claims, or proceedings arising out of the supply and delivery of calcium.

10.2 The Contractor agrees to indemnify and hold the Municipality harmless from any claims arising from the Contractor's failure to comply with the terms of this Agreement.

11.0 Force Majeure

11.1 Neither party shall be liable for any failure to perform its obligations under this Agreement if prevented by circumstances beyond reasonable control, including acts of God, natural disasters, or government restrictions.

12.0 General Provisions

12.1 This Agreement represents the entire agreement between the parties regarding the crushing of gravel and supersedes all previous communications, representations, or agreements, either oral or written.

12.2 The Contractor shall not be entitled to assign this agreement without the prior written consent of the Municipality.

12.3 This agreement shall go to the benefit of and be binding upon the Municipality, the Contractor and their respective executors, administrators, successors and assigns.

12.4 Any amendments to this Agreement must be in writing and signed by authorized representatives of both parties.

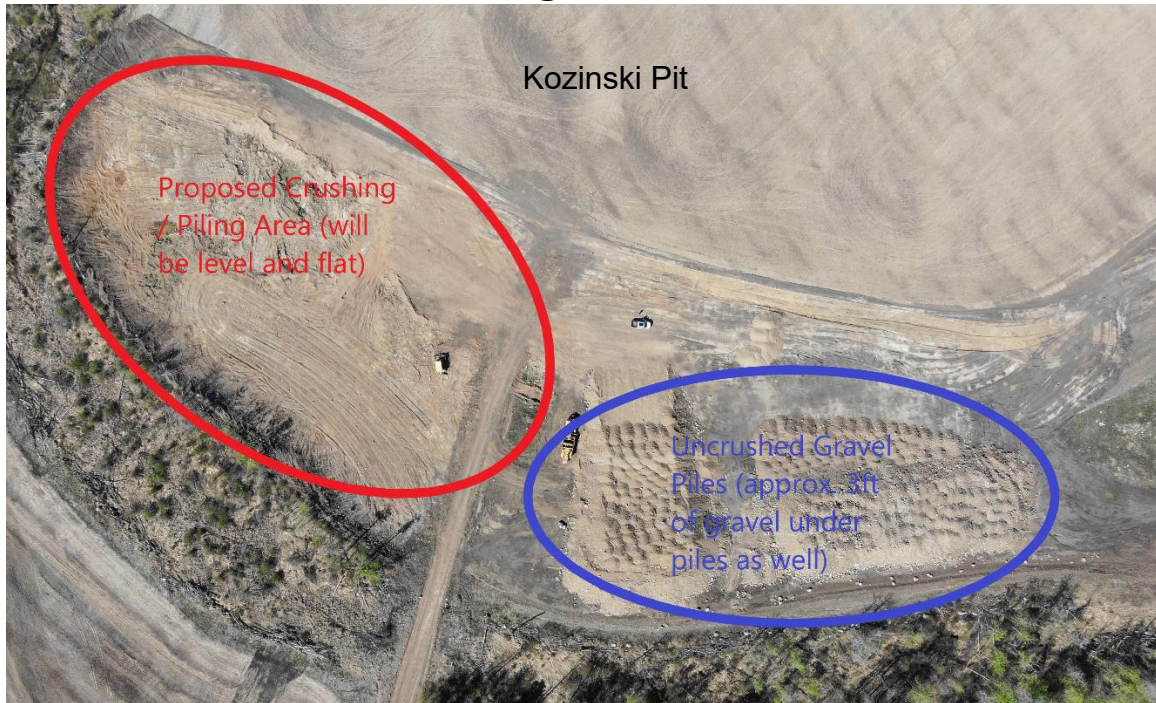
